About Truvaga 350

Truvaga 350 is a handheld wellness device designed to help you feel calmer, think more clearly, and sleep more deeply, naturally. It uses gentle electrical stimulation to activate the vagus nerve, helping your body shift out of stress (fight-or-flight mode) and into a state of balance (rest-and-digest mode).

In just 2-minute sessions, Truvaga 350 supports:


- Less stress
- Better sleep
- Sharper focus
- More calm

Safe, non-invasive, and easy to use, Truvaga 350 fits into any daily routine. For best results, use consistently, twice a day. Over time, the benefits build and last.

Step 2: Prepare your Truvaga 350



- Find your vagus nerve by placing two fingers on either side of your neck to locate your pulse. Your vagus nerve passes through the neck in this area.
- Make sure your neck is clean, dry, and free of barriers such as jewelry.
- With Truvaga 350 off, remove caps and practice placing it in this location.
- Make sure to place Truvaga 350 vertically so the electrodes are one above the other, in the exact spot you found your pulse.




Truvaga 350's electrodes should line up with the following landmarks:

- Just below the lower jaw (grey)
- Over the pulse; this is the application site (orange)
- Lined up next to the windpipe (blue)
- In front of the large muscle at the side of the neck (yellow)



NOTE: Only use Truvaga 350-supplied gel. Please visit Truvaga.com to purchase more gel, if needed.




NOTE: The display screen will indicate the number of sessions remaining (each Truvaga 350 comes with 350 sessions).



Position Truvaga 350 vertically on your neck as you practiced earlier. Both electrodes must be completely in contact with your skin for Truvaga 350 to effectively activate your vagus nerve.


Using your Truvaga 350

Truvaga 350 can be used anytime, but we recommend at least twice a day, once in the morning and once at night. If you're experiencing a particularly stressful day, trouble sleeping, or difficulty focusing, you can use it as needed, up to 24 times per day.

For best results, use Truvaga 350 consistently. Some users feel noticeably calmer within the first 7 days, but the greatest benefits, like deeper relaxation, improved focus, and better sleep, typically build over 30 days with regular use.

NOTE: Truvaga 350 comes preloaded with 350 sessions

One 2-minute session in the morning





One 2-minute session in the evening

Step 3: Start your session

- Keeping the electrodes firmly against your neck, increase the intensity (with the (+) button) until you notice a tingling sensation or a slight muscle contraction at the corner of your mouth.
- You should feel a tingling sensation that is strong but comfortable, this is typically felt between intensity levels 15-25.
- During your session, you can make small adjustments to the intensity level and placement, as needed.
- Placement: If you don't feel a lip-pull or slight muscle contraction when using Truvaga 350, make small adjustments to the placement on your neck until you do. It can make all the difference.
- Intensity Level: You can increase or decrease the intensity level by pressing the (+) or (-) buttons



- Once you've found the right location and intensity level, hold Truvaga 350 in place until it beeps twice. This indicates the end of your 2-minute session. Truvaga 350 will automatically turn off after your session.
- When finished, remove Truvaga 350 from your neck and wipe off any remaining gel on Truvaga 350 and your neck using a soft cloth or tissue. Replace the caps, and you'll be ready for your next session.

Helpful Tips

- You will likely feel muscle contractions at the application site and may experience a lip pull. These are normal and should stop after the session is complete. If muscle contractions are too strong or uncomfortable, try:
- · Lowering the intensity level by pressing the (-) button
- Repositioning the electrodes on the neck over the pulse and slowly increasing the intensity level again by pressing the (+) button

If the intensity level is still too strong, stop the session and turn Truvaga 350 off by pressing and holding the (+) and (-) buttons.

- Truvaga 350 has a limited number of sessions.
- The number of sessions remaining can be viewed by turning on Truvaga 350.
- Increasing the intensity level past 3 will start a session.
- There is a delay feature to prevent accidental starts.
- Attempting multiple sessions in a row will result in Truvaga 350 not turning on immediately. To resolve, wait 10 seconds before turning it on again.
- You may need to apply additional gel between sessions.
- You should not use soap, hand sanitizer, detergents, or other cleansers when cleaning Truvaga 350.

Troubleshooting

- Truvaga 350 does not turn on Restart your Truvaga 350 by pressing and holding the (+) and (-) buttons at the same time for 10 seconds and then release. Wait 5 seconds and turn on again. If Truvaga 350 still does not turn on, contact us.
- Flashing green light with "Err" code Restart your Truvaga 350 by pressing and holding the (+) and (-) buttons at the same time for 10 seconds and then release. Wait 5 seconds and turn on again. If Truvaga 350 still displays "Err", contact us.
- Flashing green light with "Lo" code Your battery may be low which likely means you have used up most of your 350 sessions. You can continue to use your Truvaga 350 until all sessions are done.
- Flashing green light with "O" code Congratulations, you've successfully used all 350 sessions! It's time to order your next Truvaga 350 on truvaga.com. If you have any questions or need support, please contact us.

WARNINGS WARNINGS

Do not use Truvaga 350 if:

- · You have an active implantable medical device, such as a pacemaker, hearing aid implant, or any implanted electronic product.
- · You are using another product at the same time (e.g., TENS Unit, muscle stimulator).
- · You are driving, operating machinery, or during any activity that may put customer at risk
- You are in the presence of strong electromagnetic fields, such as MRI scanners.
- · You are in an explosive atmosphere or in the presence of flammable gas mixtures.
- You have an open wound, rash, infection, swelling, cut, sore, drug patch, or surgical scar(s) on the neck at the application site.
- · You have wet skin, are in the water, or just stepped out of the water (e.g., shower, bath, pool).

It is not recommended to use Truvaga 350:

- If you have had surgery to cut the vagus nerve at the neck as it may not be effective.
- If you are younger than 12.
- If you are pregnant or breastfeeding.
- · More than 24 times a day.



PRECAUTIONS

- Truvaga 350 should be used only as described in the User Manual.
- · Only use a Truvaga 350-supplied conductive gel.
- Do not apply Truvaga 350 across or through the head, directly on the eyes, covering the mouth, on the chest, on the upper back, or over the heart.
- Do not use Truvaga 350 if there are signs of damage or defects.
- · Do not use if the light is flashing green and "Err" is displayed on the screen when the product
- Do not submerge Truvaga 350 in water; it is not water resistant.
- · Store in a safe location out of reach of children.
